General Instructions

This form is used to apply to individual U.S. Department of Education (ED) discretionary grant programs. (1): Indicate whether or not your organization has an Indirect Cost Rate Agreement that was approved by the Federal government. If you checked "no," ED generally will authorize grantees to use a temporary rate of 10 percent of budgeted salaries and wages (**complete (4) of this section when using the temporary rate**) subject to the following limitations:

(a) The grantee must submit an indirect cost proposal to its cognizant agency within 90 days after ED issues a grant award notification; and

(b) If after the 90-day period, the grantee has not submitted an indirect cost proposal to its cognizant agency, the grantee may not charge its grant for indirect costs until it has negotiated an indirect cost rate agreement with its cognizant agency.

(2): If you checked "yes" in (1), indicate in (2) the beginning and ending dates covered by the Indirect Cost Rate Agreement. In addition, indicate whether ED, another Federal agency (Other) or State agency issued the approved agreement. If you check "Other," specify the name of the Federal or other agency that issued the approved agreement.

(3): If you check "no" in (1), indicate in (3) if you want to use the de minimis rate of 10 percent of MTDC (see 2CFR § 200.68).

If you use the de minimis rate, you are subject to the provisions in 2 CFR § 200.414(f). Note, you may only use the 10 percent de minimis rate if you are a first-time Federal grant recipient, and you do not have an Approved Indirect Cost Rate Agreement. You may not use the de minimis rate if you are a State, Local government, or Indian Tribe, or if your grant is funded under a training rate or restricted rate program.

The 8 percent limit also applies to cost-type contracts under grants, if these contracts are for training as defined in EDGAR § 75.562(a). If a **non-governmental entity** that receives a grant under a training grant program does not have an approved indirect cost rate and wants to recover indirect costs, it may use a temporary rate of 10 percent of budgeted direct salaries and wages, but it must submit an indirect cost rate proposal to its cognizant agency for indirect costs within 90 days after ED issues the GAN. After the 90-day period, the government entity may not charge its grant for indirect costs until it has negotiated an indirect cost rate agreement.

Section C – Budget Narrative

Since Pennsylvania's ESSER Fund Certification and Agreement was approved on May 5, 2020, a state statutory provision was enacted (on May 29) that directs the transfer of the entirety of the ESSER SEA reserve (\$49.8 million) from PDE to the School Safety and Security Fund, a state appropriation maintained and implemented by the Pennsylvania Commission on Crime and Delinquency, a non-executive state agency. Additional statutory provisions were enacted on June 5, 2020 that specifically direct how the funds in the School Safety and Security Fund, including state funds and the ESSER SEA reserve, must be combined and distributed and for what purposes the funds can be used.

Neither the transfer of the ESSER SEA reserve or the provisions related to how the ESSER SEA reserve must be distributed and for what purposes as now mandated by the new state laws referenced above is consistent with Pennsylvania's approved ESSER Fund Certification and Agreement. To ensure compliance with all applicable Federal requirements, PDE has sought direction from the Office of State Support on 6/30/20; 7/24/20; 7/29/20; and 7/31/20.
