#### Brief description of proposed project, including project activities:

Shelby County Community Schools Partnership (SCCSP) will focus on the high-needs communities of Frayser, Northaven and Millington within Memphis - Shelby County, Tennessee to implement and evaluate the full-service community schools (FSCS) model in multiple types of schools (charter, traditional public, municipal) to improve outcomes for students and families and to determine best practices that can be scaled across the county. Activities will include: implementation of four pillars of FSCS model; development, implementation, and evaluation of collaborative processes among partners, families, and students; addition of two new pipeline services and expansion of three existing pipeline services in all six participating schools. New pipeline services include Integrated Student and Family Supports and Early Childhood Services. Existing pipeline services to be expanded include High-quality In-and-Out-of-School Programs, Community-based Support for Students During Times of Transition; meeting student and family SEL needs through a multi-tiered system of supports; reducing community and school violence through systemic change.

#### Summary of project objectives and expected outcomes:

*Goal:* To improve coordination, integration, accessibility, and effectiveness of services for children and families through six full-service community schools in Northwest Memphis (3,376 students).

**Performance Objective 1:** To increase the percentage and number of individuals within the target area that receive services during each year of the project.

*Outcomes:* hire 5 new coordinators; convene weekly committee meetings, monthly workgroup meetings, quarterly consortium meetings

**Performance Objective 2:** To provide expanded and new pipeline services to high need students and families to ensure that children are prepared for kindergarten and achieving academically.

*Outcomes:* improve kindergarten readiness by 5% annually; improve reading proficiency and math proficiency by 3% annually; increase number of Ready Graduates by 2% annually; reduce summer slide between grade 5 and 6 in reading and mathematics

**Performance Objective 3:** To provide expanded and new pipeline services to high need students and families to ensure children are safe, healthy, and supported by engaged parents.

*Outcomes:* increase parent/family participation in family and community events by 10% at all 6 schools; increase % of students by 5% who answer favorably for questions about "Sense of Belonging" (in the School Climate Survey); reduce in and out of school suspensions by 50%; Improve school climate by 5%; reduce absenteeism by 20%; reduce school suspension by 10%; increase % of students reporting feelings of safety by 5%
