

Title III EDFacts Data Submission

This technical assistance document aims to assist stakeholders in understanding the Title III data collections that are submitted to the U.S. Department of Education (ED) via EDPass. Please refer to the EDFacts file specifications or contact edfacts@ed.gov for official guidance. The submission details and reporting requirements are only applicable to school year (SY) 2022–23.

About the Data

The **U.S. Department of Education (ED)** collects most Title III data for English learners (ELs) from state educational agencies (SEAs) through **EDFacts.**

Data Groups and File Specs

EDFacts data are organized according to topical data groups (DGs) and file specifications (FSs).

DGs contain specific pieces of information gathered from the SEAs.

FSs outline rules for submitting data in DGs and detail changes from previous versions of the FS.

Reporting Levels and Periods

Depending on the FS, data are collected at the **school**, **local educational agency (LEA)**, and **SEA levels**. For a single data point, an SEA may need to submit three files: one containing school-level data, one containing LEA-level data, and one containing SEA-level data.

Reporting periods for the data also vary by FS. Data can be reported for the entire school year, for the state ELP assessment testing window, or based on the student population on October 1 (or the closest school day) of that school year.

Responsible Parties



EDFacts Coordinators ensure that data files are transmitted in a timely manner and errors in data are corrected. They work with the SEA's Title III Coordinator and other state officials, such as data specialists and assessment coordinators, to collect and review EL and Title III-related data files.

How to Submit



As of the SY 2022–23 reporting period, most Title III data will be collected through a new system, called **EDPass**. The <u>Business Rules Single</u> <u>Inventory</u> (BRSI) provides data quality rules that are applied to data prior to SEAs submitting to ED, and is an important resource for SEAs as they review the data submitted by LEAs and prepare for the data submission to ED.

Submission Details

When to Submit



SY 2022–23: *Due January 24, 2024* ED*Facts* Coordinators are required to submit

all Title III-related EDFacts data files by the submission due date. Be sure to check the EDPass Bulletin Board for any updates to the due date or other changes.

In EDPass, business rules are applied to data pre-submission (see <u>BRSI</u>). If a data flag is triggered, EDFacts Coordinators will review data quality results and either revise the submission or add notes to provide context. See the <u>Guide to Collecting and Reporting</u> <u>Title III Data</u> for situations that can potentially result in data flags and the appropriate notes to submit. **Data are considered final as of the due date, with no resubmission period.**
