**GAO Report: COVID-19 Relief Funds - State Experiences Could Inform Future Federal Relief Funding:** The Government Accountability Office (GAO) released a report describing how some states planned for, used, and reported on COVID-19 relief funds; challenges that some states experienced in using COVID-19 relief funds; actions taken to address those challenges; and how the experiences of some states could inform future federal relief funding. **Link:** <https://www.gao.gov/products/gao-24-106152>

**GAO Report: Federal Spending Transparency - Opportunities Exist to Improve COVID-19 and Other Grant Subaward Data on USAspending.gov:** The Government Accountability Office (GAO) released a report summarizing findings from a series of tests on roughly 6 million grant subaward records available on USAspending.gov, reviews of the legal framework that governs subaward reporting, and interviews with officials from selected agencies to understand how they support subaward data quality. **Beware of emails soliciting payment for SAM.gov registration or renewal:** Grantees and other entities are reporting they have received sophisticated emails that appear to be from SAM.gov. These emails include a phone number that is not the GSA Help Desk, but rather will solicit payment to renew registration. **SAM.gov is free and will never ask for payment.** Please see this article from GSA, [Don't Take the Bait: Beware of Misleading Marketing, Imposters, and Phishing](#) for more information.

**Optional Template for LEA-Level MOEquity Data, Due 12/31/23:** The [Notice of Final Requirement](#) establishes requirements for publishing LEA-level maintenance of equity data to demonstrate that LEAs are maintaining both fiscal and staffing equity in fiscal years 2022 and 2023. **The deadline for SEAs to publish this applicable LEA high-poverty school data for FY 2023 is 12/31/23.** FY 2023 data includes a comparison of school year 2021-2022 data with school year 2022-2023 data to determine whether high-poverty schools within applicable LEAs received disproportionate per-pupil funding and/or full time equivalent (FTE) staff. The Department is providing [this optional template](#) for SEAs to collect and submit data from LEAs. LEAs that are excepted from the LEA-level MOEquity requirement in FY 2023 are not subject to this reporting requirement.

**Strategic Planning for Continuing Recovery (SPCR) initiative:** States are invited to form cross-functional teams to participate in the *Strategic Planning for Continued Recovery (SPCR)* initiative and share priorities and preferences for types of support in planning for sustaining especially high-leverage strategies that have been funded by American Rescue Plan and other COVID-relief funds. Please complete this online [State Invitation and Interest Form for SPCR Initiative](#) to share a few of your State's priorities and indicate members of your State's cross-functional team, including a key point of contact.

**ARP Liquidation Extension Request Information:** The Department has communicated that the general liquidation extension that has been available under the CARES and CRRSA Acts will be available for ARP Act programs. Additional information, including a request template and updated frequently asked questions document will be available this fall.
