Brief description of proposed project, including project activities: The Grand Avenue Learning Corridor Partnership (GLCP) is comprised of two New Haven Public Schools, Fair Haven School and the Family Academy of Multilingual Exploration (FAME). Both schools are Title 1 and located on the main street of the high-needs Fair Haven neighborhood in New Haven, Connecticut. The Partnership provides a continuum of coordinated supports in order to meet the academic, social, emotional, and health needs of children and families. Four service pathways advance the project goals: 1) High-Quality Schools and Learning, 2) Schools as Community Centers, 3) Family Support and Leadership Development, and 4) Improved Physical and Behavioral Health.

Summary of project objectives and expected outcomes: The Partnership's objectives aim to increase the following: (1) Families' Utilization of Quality Early Childhood Programs; Educator and Caregiver Understanding of Students' Early Development; Students' Kindergarten Readiness; and Student Academic Achievement in Grades K-8. (2) Effectiveness of Social, Emotional and Behavioral Health Support for Families; Caregivers' Ability and Opportunity to Engage in Children's Educational Experiences; Student Leadership and Positive Engagement in School and Out-of-School Activities; and Families' Utilization of Available Health Services. (3) Staff Training in Restorative Practices; Community organization program offerings inside schools; Caregiver knowledge of, access to, and positive assessment of community resources. (4) Community Partner engagement in School and Out-of-School Activities. Measurable outcomes tied to each objective will demonstrate the project's effectiveness.
