Pipeline services to be provided at the start of the grant include 1. High-quality early childhood education programs 2. Supporting high-quality school and out-of-school time programs, 3. Social, health, nutrition, and mental health services and supports, and 4. Postseconary and Workforce Readiness. Pipeline serviced to be added during the grant include 1. Support for school and workforce transitions, 2. Family and Community Engagement Supports and 3. Juvenile Crime Prevention and Rehabilitation Programs. As a capacity-building applicant, major program activities will include implementing at least two new pipeline services and ensuing a Community Schools Coordinator is located at each school location.
