

This resource provides information on select **federal education funding sources and technical assistance** that can support schools to combat chronic absenteeism and boost everyday attendance.

# **FORMULA GRANTS**

Schools may use the following formula grant funds to promote student engagement and everyday attendance:

**Title I, Part A** funds may be used on evidence-based strategies to increase attendance and instructional time.

**Title II, Part A** funds may be used by schools to implement evidence-based professional development programming, focused on increasing student engagement.

**Title IV, Part A** funds may be used to improve school conditions and create safe, positive, and healthy learning environments that support consistent student attendance.

**Title IV, Part B** (Nita M. Lowey 21st Century Community Learning Centers) funds may be used to provide out-of-school time opportunities (e.g., enrichment programs before school, after school, and during school breaks) to enhance connections between students and their school, family, and community partners and encourage everyday attendance.

**Title IV, Part E** funds may be used to strengthen family engagement, which in turn promotes daily student attendance.

**IDEA, Part B** funds may be used to support schools to compensate for lost instructional time due to chronic absenteeism of children with disabilities.

**Stronger Connections Grant program**, authorized under the Bipartisan Safer Communities Act, may be used to create safe, welcoming environments and foster regular attendance in high-needs schools.

### **DISCRETIONARY GRANTS**

Schools can apply for funding to continue innovative programs they created or expanded with recovery funds.

**Full-Service Community Schools** provide wraparound supports which help address chronic absenteeism and support student engagement.

**Promise Neighborhoods** provide comprehensive, cradle-to-career supports to students in low-income neighborhoods.

**State Personnel Development Grants** can be used by State Educational Agencies to respond to the needs of children with disabilities related to attendance, engagement, and mental health.
